2.2 Proposal of Planning

Activities proposed under each fund are as follows

1.Corpus Fund

2. Faculty Development Fund

- Expenditure on faculty members attending training in subject domain
- Expenditure on organizing in house subject area training programmes/workshops, Seminars, conferences.
- Expenditure on short term programmes with industry.
- Faculty attending capacity building programmes/management programmes

3 Equipment Replacement Fund

 Replacement of obsolete furniture and equipment including computers and related devices.

4. Equipment Maintenance Fund

- Maintenance of Furniture and Equipment including computers and related devices.
- Annual Maintenance Contract for the equipments procured under TEQIP-II
- Purchasing of consumables for the training activities in connection with the TEQIP equipments
- Purchasing new softwares for the training activities in connection with the TEQIP equipments.

BoG had an extensive discussion on the way the funds are to be spent under different heads. Director, SPFU opined that the faculty going for FDP shall choose fruitful programs in NITS or IITs. BoG decided as follows.

- 1. There has to be a scrutiny by the respective committees to ensure the quality and utility of programs the faculty propose to attend.
- 2. Ensure the participants from different colleges in the FDPs conducted inhouse.
- 3.Seed money for research shall be included.
- 4.Flight fare to be restricted for far off places in the case of faculty/staff attending FDPs or training programs. The places where one can reach through an overnight journey, flights may be avoided and second class AC fare shall be permitted in such cases. Such restriction shall not be made applicable to Principal or such persons for attending meetings.
- 5. Faculty from architecture and MCA shall be permitted to conduct FDPs in association with TEQIP departments or supporting departments.

4. Any Other Items

4.1 Ratifying the extension of the TEQIP staff

Government have accepted the continuance of one TEQIP staff (Clerk cum junior Accountant) for the smooth functioning of utilization of four funds. Hence BoG may kindly permit the continuance of the existing staff in contract basis with a consolidated salary of Rs.19,000/- per month.

Decision:

BoG approved the continuance of the existing staff till 15th Dec 2017. One Clerk cum junior Accountant to be appointed through a fresh recruitment process for the period after 15//12/2017 from among the eligible candidates and candidates having exposure in managing TEQIP projects shall be given preference in such process.

4.2 Festival allowance to TEQIP staff

As per G.O.No.107/2017/finance dated 16.8.2017, the employees in contract basis are eligible for festival allowance of Rs2750/- for the year 2016-17, if they had served for six months consecutively. This is allowable even if they were discharged from service after serving six months consecutively in 2016-17. Hence BoG may kindly permit disbursal of festival allowance Rs.2750/- each to the two TEQIP staff who had served in the financial year 2016-17.

Decision:

BoG approved the proposal.

- 4.3 Government representative from finance department strongly opined that interdisciplinary research and publications are to be encouraged.
- 4.4 Representative from APJ Abdul Kalam Technological University suggested that it is high time to initiate the works for starting centre of excellence in one or two departments.
