The agenda of the meeting was approved by the BoG . The BoG considered the agenda items one by one. The suggestions/ decisions taken on them are as follows.



**BG 5.1 Approval of the minutes of the previous BoG meeting .**

Prof. U. Rasheed Kutty , TEQIP coordinator, read the minutes of the fourth BoG meeting held on 26/03/2014 and explained the actions taken . The BoG approved the minutes.

Presented the report of Dr Premlet who visited ARAI ,Pune and mentioned that the results of Studies would lead it to patent in near future.

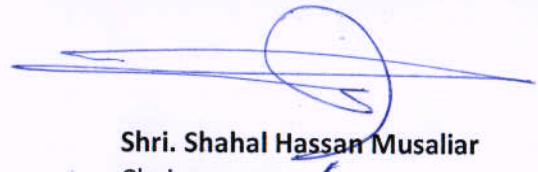
g) **Next BoG meeting**
